# Provider Meetings for Medicaid Eligibility Redetermination and Unwinding PHE Flexibilities

On February 9, 2023, the State of Montana received notice from the Secretary of the U.S. Department of Health and Human Services (HHS) that the COVID-19 Public Health Emergency (PHE) would be extended for 90 days. Additionally, the Secretary noted that based on current trends regarding COVID-19, HHS is planning for this to be the final renewal and that the PHE will end on May 11, 2023.

### **Medicaid Eligibility Redetermination**

Beginning April 1, DPHHS will begin evaluating Medicaid members' eligibility for continued Medicaid, a process called redetermination. This will be the first time in three years that most Medicaid members have gone through a redetermination, as coverage was continued without interruption during the COVID-19 pandemic.

Also on April 1, the policy of 12-month continuous eligibility will end for most adults. This will mean that changes in an individual's circumstances, such as income or household size, may lead to the ending of their Medicaid coverage, whereas previously their coverage would have continued until the end of the 12-month period since their application or last redetermination.

We know that you are a trusted source of information for Medicaid members and appreciate your partnership in helping them know what they need to do to keep their coverage. Thank you for all you do for communities across Montana.

### **Unwinding Public Health Emergency Flexibilities**

Throughout the duration of the PHE, many programmatic flexibilities were implemented at both the federal and state levels. This allowed the ability to waive or modify certain requirements in a range of areas. Of significance, many flexibilities and policies have already been made permanent. With input from stakeholders, DPHHS reviewed each flexibility and policy enabled by the PHE to best determine the range of flexibilities that should remain in place once the PHE ends.
